- Welcome/Introduction of Members**

Mrs. Adams called the meeting to order at 4:15 pm.

Mrs. Adams welcomed everyone to the 1st quarter SDMC meeting for the 2021-2022 school year. The committee members introduced themselves as: Principal, Mrs. Adams, Assistant Administrator, Mrs. Peters, Assistant Administrator, Mr. Bailey, SPED Teacher, Dr. Grover, and TA, Mrs. Joseph. The Discipline Clerk, Ms. Garcia marked herself as present in the TEAMS chat box along with the other members. The community member, Mr. Bailey will be updated.

- Reading of old minutes**

Dr. Grover read the old minutes from the 4th quarter meeting of the 2020-2021 school year.

- Review of 4th Quarter Meeting**

Mrs. Adams gave an update from the last quarterly meeting. The marque is up and running. We currently have 2 teacher vacancies, Band and Choir and 1 pending, CTE. Ms. Gamble is going to fill the Choir vacancy as an associate teacher until a teacher is located and hired. Next year we will pursue a dance instructor. We will have a teacher and/or associate teacher in every class when the 2021-2022 school year begins on August 23, 2021. Mrs. Adams also addressed

that the district didn't approve an extra teacher to double block English. Thus, we will double block Math.

Mrs. Adams reviewed the **School Improvement Plan**. *Information reviewed is listed below.*

The mission and vision statements for the 2021-2022 school year at North Forest High School have been proposed.

The mission of North Forest High School is to provide academic excellence and postsecondary readiness in order to rise above all challenges in an ever-changing global society.

Our vision at North Forest High School is to build accountable, competitive, resilient, and persistent students who will mold and shape the future of our community.

Nonetheless, we will look at the mission and vision statements during in-service so teachers and staff can have a chance to vet the statement and/or add input.

Currently, our student body enrollment is at 1100 students. During the 2018-2019 school year, student enrollment was at 961, and during the 2019-2020 school year, enrollment was at 960. The numbers for the 2020-2021 school year are not out yet.

The campus improvement plan addressed the goals of the district and North Forest:

District Goal 1: ELAR The percentage of 3rd grade students performing at students reading and writing at or above grade level in reading as measured by the Meets Grade Level Standard on STAAR will increase 8 percentage points from 42% in spring 2019 to 50% in spring 2024.

Campus Goal: English I and II will increase by 15% in achievement and increase growth points earned in ELA by 20%.

District Goal 2: MATH The percentage of 3rd grade students performing at or above grade level in math as measured by the Meets Grade Level Standard on STAAR will increase 8 percentage points from 46% in spring 2019 to 54% in spring 2024.

Campus Goal: Algebra 1 will improve overall student performance: to 75% Approaches Level, 45% Meets Level, 20% Masters Level and 50% Algebra 1 Retesters will score at the Approaches Level.

District Goal 3: The percentage of graduates that meet the criteria for CCMR as measured in Domain 1 of the state accountability system will increase 8 percentage points from 63% for 2017-18 graduates to 71% for 2022-2023 graduates reported in 2024.

Campus Goal: 80% of all students will meet a College, Career, and Military Readiness criteria set forth by the Post-Secondary partnership(s) and Texas Education Agency.

District Goal 4: The percentage of students receiving special education services reading at or above grade level as measured by the Meets Grade Level Standard on the STAAR 3-8 Reading and STAAR EOC English I and II assessments will increase 8 percentage points from 21% in spring 2019 to 29% in spring 2024.

Campus Goal: Increase daily student attendance from 89.2% to a minimum of 96% YTD
