#### ESSA Consolidated Federal Grant Application – Public Comment Period

Houston ISD is required by law to receive public comment *before* the ESSA Consolidated Federal Grant Application is submitted to TEA. [ESEA Section 8306(a)(7) and the ESSA Program-Specific Provisions and Assurances] The district estimates that it will submit the 2022-2023 ESSA Consolidated Federal Grant Application on **Friday**, **June 25**, **2022** for all ESSA grants that Houston ISD is eligible to receive.

For this year, HISD will meet this compliance requirement by implementing the following strategies: Board Item, Parent Consultation Meeting, Academic Services Memo, postings on the External Funding – Parent Engagement website, and a Public Comment Survey.

The public comment period is May 20 through June 10, 2022.

#### 2021-2022 Title I Parent and Family Engagement Campus Allocation


ESSA, Section 1116, Parent and Family Engagement (PFE) requires all Title I schools to receive additional Title I funds specifically to support PFE activities on the campus to increase student academic achievement.

The Title I PFE funds have been loaded to your campus's Title I budget. These funds must be utilized during the 2021–2022 academic school year and the deadline to expend these funds is May 6, 2022.

#### Title I Parent and Family Engagement Survey

## **Using Leftover Camp Spark Funds**

<u>IMPORTANT</u> - The fund end date (previously June 30, 2022) has been updated to **June 8, 2022** due to the fact that Summer School is no longer funded by Title I funds.

#### 2022-2023 Title I Preliminary Budget Review

Campuses will receive their 2022 – 2023 Title I Budget allocation during the Preliminary Budget Review period. The <u>Academic Services Memo</u> posted on February 28, 2022 lists action items helpful in preparing for the Title I, Part A 2022 – 2023 Preliminary Budget Review.

#### **Capital Outlay Update**

Capital outlay includes items that have a useful life of one or more years, and that are of a tangible, non-expendable nature. Capital outlay also includes lower-cost technology, such as electronic notebooks and tables, graphic calculators, eReaders, scanners, digital cameras, and electronic dictionaries, etc.

\*NOTE: All capital outlay and campus library books require specific TEA approval prior to purchase -- regardless of the dollar amount.

All new requests for TEA approval for technology and campus library books will be included in the 22/23 ESSA Application in June. A memo will post on **Monday**, **May 9**, **2022** with information regarding how to make new requests and the required forms.

#### Out-of-State Travel/Virtual PD - Update

Based on the updated "The "Ready Set Go Plan" (dated March 1, 2022), campuses are now allowed to request actual out-of-state travel. Out-of-state travel and conferences are allowed with no limitations. **A memo will post on Monday, May 9.** The TEA Out-of-State Travel/Virtual PD Form for the 22/23 SY will be released at that time.

External Funding will be accepting requests for out-of-district travel and out-of-state/virtual PD occurring between October 1 – February 28, 2023.

## **Semi-Annual Certification Update**

Principals who have employees compensated out of their state or federal grant programs budget will be required to certify these employees via OneSource.

Principals and department managers received an email on Monday, April 25, 2022, indicating the certification period is open to certify and submit the Semi-Annual Certification Form via OneSource. The due date is **May 6, 2022**.
