Purpose

- Update parents through parent conferences on the various assessments students are administered, new instructional strategies, and student performance expectations.
- Use a variety of communication tools including weekly school newsletter, classroom newsletters, school website, campus marquee, student communication logs/folders, automated call-out system, parent/teacher conferences, SDMC meetings, Parent meetings, print and voice surveys, Open House, progress reports, report cards, and assessment data.
