Student Contract

I, _____, (ID Number _____) understand that I must abide by the following items in order to be on the Chavez FFA Show team:

- Be a dues paid FFA member in good standing each year I show an animal.
- Pass all classes EVERY grading period
- Will purchase an FFA Official Jacket and dress to be worn the day of the auction if I do not already own.
- Will only be allowed to show and sale one market animal for the school show.
- Must be present during the week prior to the show to groom my animal on the assigned day, to be determined.
- Must go to the farm to care for my animal EVERY day. Cattle owners will be required to go 2X/day.
- Will be required to put in 15 hours of community service at the farm facility per semester (Fall, Spring, and Summer)

I understand that if I do not go to the Ag farm to care for my animal and sign in each day, I will have \$50.00 deducted from the sale amount of my final sales total for **each day** that I miss. I understand that in order to not receive a deduction, I must notify my ag teacher of each absence AND I am responsible for securing my animals care the day of my absence. **I understand that if I do not notify her of an absence PRIOR to that absence, I will automatically receive a deduction regardless of the reason for my absence. I am aware that if I miss more than 3 days of unexcused attendance at the barn or without permission from my ag teacher, I will be required to remove my animal from the farm or my ag teacher has the right to remove it.**

I am aware of the show dates, **March 28- April 2**, and understand that I **MUST** be present the **entire week** of the show after school and at the auction on Saturday, as well as the clean up day, Saturday April 14 following the sale.

I, _____, understand that if I fail **ANY** six weeks period, I will forfeit my right to participate at ANY livestock show. This means that I will not be allowed to show my animal at the school show or auction off my animal at the school auction.

I understand that I will not be reimbursed any monies that have been paid for my animal or any donations that have been given for my animal. Tutoring/academic assistance is available throughout the school year to assist me with this during the lunch hour and additional time can be provided upon request. This includes ALL livestock species, (Market AND Breeding)

I understand that I have 10 days from the day I am ineligible to show to remove my animal from the farm/school. If my animal is donated back to me after the auction, I have 10 days to remove it from the farm/school facility. All breeding animals will be required to be removed by April 30th following the school show.

I, _____, understand that if I post anything negative, written or picture, about myself, another FFA member or the Chavez FFA chapter on any social media website, email, or other source, I will **immediately** be terminated from the FFA program and will forfeit my rights to participate in any and all FFA activities for the rest of that year and future years as long as I am in school. This means that if I have an animal project, I will not be allowed to show that animal nor will I receive any refunds or reimbursements for that project, and understand that I am ineligible to show and have 10 days to remove my animal from the school facility from the day I am notified that I have been removed from the program.

I understand that my attitude and behavior at the farm and school is being monitored and that I have the responsibility to stay positive and not bully or pressure other students. My interaction with my peers will be

positive. If I interact with any other FFA member or the FFA instructors in a negative fashion, I understand that I can be removed from the ag facility and not be allowed to participate with any FFA project.

Parent Contract

I, _____, understand that there will be at least one parent meeting per month, starting in September, and that I agree to be present at these meetings. I understand that these meeting are **MANDANTORY** for me to attend and I understand that if I miss more than one of these meetings, my student will not be eligible to compete in the show or sale their animal at the auction and that no monies will be refunded.

I understand that I will be required to be present at the school show, April 1 during **my** student's competition **AND** April 2nd at the auction of my student's project. I also understand that I/my student will be required to submit **at least** \$150 of items for the silent auction OR I/student must secure **at least** 1 belt buckle sponsor by the due date set forth by the ag teachers. I will also understand that I/my student will be required to sale a minimum of \$100 in adds for the add book that will be distributed at the auction. **Total contributions- \$250.** I understand that the amount of \$250 will be deducted from my students check if I fail to make this contribution through the above donations. I also understand that I must secure a buyer for my student's animal for the minimum sale amount or my student may not be allowed to auction their project.

I understand that I will be required to pay my alumni dues of \$20 for my student to be eligible to participate in the school show by December 8th, 2015. Failure to do so by the deadline will result in my student losing their ability to participate in the school show event.

I understand that there are certain requirements that my child must complete to be eligible to participate in the show and auction including but not limited to: purchasing and FFA Official jacket, pass all classes every grading period, be present EVERY day of the school show event, properly care for their animal project, etc.

I, _____, understand that my student, _____, must abide by the above policy and that I will not be reimbursed for my students project if he/she fails to pass a six weeks grading period or fails to comply with the barn agreement and any other part of the requirements set forth in the Animal Welfare agreement and Student contract.
