## ❖ Welcome

## ❖ New Business


- **PTO** – We just have elections during our last parent meeting. We have four returning member and new members,
- **Enrollment** – We have 318 students so far. We have four more incoming this week.
- **Attendance** – Our attendance has been pretty low the past two weeks. We have had several students with infections (pinkeye, flue, stomach virus). Staff attendance is on target.
- **Budget** – Our budget is not looking very good. Last week we had a meeting with central and they want us to return 170K due to low enrollment. They want us to cut to positions. They have not shared the specifics yet. They are still making decisions. The only thing for sure is the amount of money we must return. We are trying very hard to enroll as many students as we can.
  - **Title 1** – We gave us very limited funds in this area. I am not sure if the administration is changing the way they distribute the funds. According to the new guidelines 14% of the students we have, do not qualify under income. If we fall under 80%, we may no longer qualify as a campus wide title I participation.
  - **GF1 Funds** – Right now we have 60K to operate. I offered to return some of these monies back in order to save some positions. I am also closing two TA vacant positions in order to avoid REED some staff. We are waiting to get guidelines as what positions they want us to cut.
  - **Positions** – We added some staff members. Now we have REED two of them. We were told that the first criteria were going to be the last one hired on the district, second certification, third are of need.
- **Safety Concerns** – The three biggest concerns that I have been sharing to the district are; Number 1, the playground. We finally we have been able to buy the mulch to place on the jungle area. I am still concern with the high of the retention wall. I want it to be lowered about 4 inches to make easy for them to avoid accidents. Safety number 2, the gate that connects playground to the parking lot. Safety number 3 is the perimeter fence. It is in very bad shape. They have come to do some repairs, but it is has not been fixed in a way that is safe for students and staff.
- **Action Plan** – Has been submitted for the third time. This time it has been revised by my boss.
