- Welcome/Celebrations
 - o **Rankings** publishing of rankings of TX schools we are #3 in HISD, we are #24 out 2008 HSs in TX, and 159 in the Nation. We are so proud of the work our academic teachers do!

Magnet funding is intact which is wonderful. Thankfully that PTO and Friends can help us absorb some of the impact with their support. However, Dr. Rivas noted this will impact staffing and those affected will know soon.

Let Admin know if teachers have issues with students and support will be there. Allison askes about NGs after the 24th reporting. Student monitoring is critical during this time to ensure safety.
