## Key Action: Improve Special Education Instruction and Service Delivery

Indicators of Success:

> The average score for Special Education teachers in the **Planning** domain on the SPOT Observation form will be 1.0 at MOY, improving to 1.5 at EOY (end of year).

> The average special education teacher score in the **Engage and Deliver** domain on the Spot Observation form will be 3.5 at MOY, improving to 4.5 at EOY.

> The classroom accommodation spreadsheet for special education students will be 100% populated at BOY (Beginning of the Year) and monthly teacher gradebook checks will be 90% at MOY and 100% at EOY.

**Key Action: Campus will improve performance for Hispanic student in math achievement** Indicators of Success:

> By June 2025, 44% of Condit's Hispanic students will reach the achievement target in math as defined by TEA Domain 3 accountability.

> The average teacher score in the **Monitor & Adjust** domain on the SPOT Observation form will be 2.5 at MOY, improving to 3.5 at EOY.

**Key Action: Campus will improve performance for Hispanic students in reading achievement** Indicators of Success:

> By June 2025, 70% of Condit's Hispanic students will reach the achievement target in reading as defined by TEA Domain 3 accountability.

> The average teacher score in the **Engage & Deliver** domain on the SPOT Observation form will be 3.5 at MOY, improving to 4.5 at EOY.

## Key Action: Campus will improve performance for Emergent Bilingual students in reading achievement.

Indicators of Success:

> By June 2025, 49% of students will grow one level of proficiency, defined as SY23-24 composite to SY24-25 composite on TELPAS.

> By June 2025, 60% of Emergent Bilingual students will meet their individual growth target on 2-8 NWEA MAP Reading.

> By May 2025, 60% of EB teachers will score 8/10 or higher in Domain 2 (Monitor & Adjust and Engage & Deliver) as measured by the monthly average spot score for the second semester.
