1. Welcome - Introductions
2. Safety Committee Updates
 - a. Condit passed it's last HISD Risk Management site visit - the goal is to see if the building is secure and ensure intruders cannot enter campus. Condit is fortunate to have a building that can be secured daily.
3. Ms. Nieto, Title 1 Parent and Family Engagement Committee
 - a. Students are more successful when parents are engaged in their child's education, topics are important for better attendance.
 - b. Topic ideas were generated for the next few Title 1 meetings - Leader in Me, restorative practices at Condit, cybersafety, testing, enrichment programs, helping students prepare for assessments (STAAR, high frequency word evaluation, etc.), managing test anxiety, accessing digital resources through Clever, developing solid routines for success at home, monitoring digital access at home.

5. SDMC Voices of Concern

- a. Concerns about safety protocols; can restrictions begin to be eased for times like recess, lunch, and field trips. Response: Condit will continue to follow the HISD Ready Set Go Plan for safety guidelines, which still indicates lunch outside or in the classroom as the best way to maintain distance. Regarding field trips, those are now permitted and grade levels are planning field trip learning experiences for the second semester.
- b. Concern about GT programs - why was there a change from last school year, students don't appear to have different work based on ability. Response: Different students need different versions of the same academic standards, for advanced students it can often mean compacting out of a

topic and working at content at different levels and different interests; knowledge level versus application level. The model hasn't changed from previous years, it has just been applied to all classes. In past years identified GT students were clustered in classes that were mixed ability, this year is the same organization - identified GT student clustered in mixed ability classes. It was suggested that the campus better articulate this to parents so there is better understanding.

- c. Concern: Request for school uniform.. Response: one parent shared they previously had kids at a school with uniforms and didn't see the difference. If this was going to be considered we would need to do a schoolwide survey. Teachers shared they don't see a need at this time. The concern mentioned research that showed effectiveness of school uniforms, several members wanted to read that research. The improvements mentioned in the concern are currently addressed at Condit through community building. Also, adding something like this means an additional admin requirement to monitor and respond to dress code violations.
 - d. Concern about masking while outside - Masks are optional while outside, according to HISD policy. Mr. Greenberg to reiterate policy to teachers in case there is any lingering confusion.
