#### **1. Restroom Doors**

- a. A and B have been locking RR doors upstairs the last few days
- b. Have been opened during transition and advocacy.

#### **2. Safety**

- a. Person at front is the initial contact with visitors.
  - i. Changes prior to buzzing parents/visitors/students in- use the intercom to speak to the person(s) to determine purpose.
  - ii. Students who leave campus and return: We are vigilant and at doors to receive students. We will search because student walked off campus.
  - iii. DAEP is not accepting for current year, but if we have documentation, we can submit for start of year.
  - iv. Ms. Mallet- can we send parent communication in all languages and are we clear about district policy or are parents aware of the policy with searching students.
  - v. Ms. Williams: Has had entire class searched. I have called admin to search because I suspected student of vaping.

- vi. Ms. Gage- Title I- document for purposes of Title I with Ms. Winfrey and the Parent Letters.
- vii. Mr. Oliver- Does campus know that allowing someone into building (our problem is not necessarily front door, but the other doors) Do students know it is a safety issue. Students need to know the severity of the safety concern by opening doors and allowing other students in.
- viii. Ms. Gage-I don't let staff in that I don't recognize including maintenance personnel that are not coming in through the front door.
- ix. Failed the audit in the area of teachers keeping doors locked.
- x. Staff will be strategically stationed in areas to support with transition/safety.
- xi. Question about announcing the intruder (if this is not a district requirement) could we have IDs with codes.

### **3. Dress Code 2023-2024**

- a. Student IDs- Material has been ordered.
  - i. Should be visible.
  - ii. Should not cover pictures.
  - iii. Plan for students who lose/forget ID.
  - iv. Teachers/staff need to be aware of IDs so we can address students who aren't wearing one.
  - v. Can we place the student Admin/Cohort/Academy on Front
- b. Dress
  - i. Proposal
    - 1. POLOs good (gray, blue, black)
    - 2. T-shirts with school emblem only or spirit shirts
