Q2 Meeting Date: 1.13.2025

- Welcome Mr. Greenberg explained that this SDMC meeting would focus, nearly entirely, on providing the district required feedback on the proposed Teacher Excellence System (TES). Mr. Greenberg mentioned that some SDMC members attended the district TES Information session and the recording was emailed to the entire SDMC with this meeting's outlook invite.
- 2. Teacher Excellence System (TES) SDMC Recording Mr. Greenberg showed the pre-recorded slides to provide context for selecting one version as a committee.
- 3. TES One-Pager and FAQ Mr. Greenberg provided two handouts at the start of the meeting that would address frequently asked questions about the TES proposed.
- 4. Preview TES framework options Mr. Greenberg presented the options for the TES and the committee discussed the positives and negatives of each. The committee shared concerns about the validity of student surveys at the elementary level and how that could be a lot of time spent on that task. The committee also mentioned the strength of options A,B,C based on the amount of local control the campus would have including coaching and goal setting.
- 5. SDMC selected Option A, where the action plan is included as part of the system, but the student survey is not.
- 6. Campus Action Plan Goals Mr. Greenberg provided an update on the Indicators of Success associated with Condit's 2024-2025 Action Plan; below is a chart of the updates. While some MOY data is available now, the EOY data won't be available until the Spring.
