# **Key Actions**

**Key Action 1:** Increase the level of student/teacher engagement, through the use of multiple response strategies to demonstrate student growth of 15% in reading and math as measured on the NWEA Mapping BOY and EOY.

#### **Strategic Priorities:**

Expanding Educational Opportunities, Transforming Academic Outreach, Cultivating Team HISD Talent

**Indicator of Success 1:** An indicator of success for this key action will be reflected on an increase of teacher SPOT observation ratings and student engagement/active participation in daily lessons.

**Indicator 1:** Out of 51 classroom spot observations by the building leadership team, 60% of the observations will align with executive leadership calibration walks in the fall. This percentage increases to 80% by Spring 2024.

**Indicator 2:** Monthly tracking for 100% of teacher ratings in the area of Engagement on spot observations.

**Indicator 3:** Using Multiple Response Strategies, student participation will be at 60% by November. This number will increase to 80% by February.

**Indicator 1:** 100% of teachers will implement student's accommodations and meet all compliance documentation in the prescribed time frame (every six weeks).

Indicator 2: 100% of students will have updated IEP goals and progress monitored every six weeks.
