### **<u>COVID-19 Update</u>** (Lisa Blackmon-Jones)

The timeline for the reopening of schools is as follows. For details, visit www.HoustonISD.org/Reopening.

Date	School Reopening	
September 8, 2020	First virtual day of school	
October 19, 2020	First day of face-to-face (instruction phased-in)	

Note: The first semester of remote learning for parents choosing on-line only instruction is September 8, 2020–January 29, 2021. Parents have the option to choose remote instruction for the fall semester (through January 29, 2021) or for the entire school year (through June 11, 2021).

Upon the reopening of schools, top-priority health and safety protocols will be in place for the welfare of students and staff.

- <u>Health and Safety Protocols</u>: The Communicable Disease Plan (CDP) Task Force has placed its plan on the HISD website. The plan stipulates that principals and building supervisors will identify wellness teams to screen students and staff.
- <u>Enhanced Safety Protocols</u>: These procedures include social and physical distancing, wearing masks in all HISD buildings and schools, cleaning and disinfection as needed, and infection control. Students will be encouraged to stay home if ill and employees will be requested to immediately report positive COVID symptoms to their supervisor. If there are COVID positive cases, HISD schools and buildings will be closed and cleaned.

# • <u>Emergency Drill Protocols</u> (Alexis Licata)

Once students return to school for face-to-face instruction, all required drills, i.e., intruder, fire, evacuation, shelter-in-place, etc. will be handled with social distancing in mind. Risk Management will be working with each campus to ensure that they have an appropriate plan in place for required drills during the pandemic.

### <u>Consideration and Selection of Storage Locations for Bleeding Control Stations on</u> <u>Campuses</u> (Lisa Blackmon-Jones)

Consideration was requested to select local storage locations for bleeding control stations/stop the bleed kits throughout the district. Upon motion by Chief Pedro Lopez, seconded by General Manager Business Solutions Yesenia Taylor, the consideration was presented.

The number one cause of preventable death after injury is bleeding. Bleeding control stations (stop the bleed kits) would be stored locally; located in nurses' offices and also stored in AED cabinets throughout campuses and buildings for easy access. The kits would contain a chest shield, a tourniquet, gauze, quick clot gauze, scissors, gloves, and a blanket.

The motion passed with a vote of ten in favor and four abstentions.

## Comments/Suggestions:

Sergeant Brown: Since we are not in the traditional stages of school, this might be a good opportunity to expand the training of the stop the bleed kits. The nurses are prepared, and it would be good to have more individuals, on campus, prepared to use the equipment, if needed.

Lisa Blackman-Jones: Last year we had a training for people from each school and department. Principals were notified to send at least two people, excluding the nurse, for the stop the bleed training. We can also start doing more classes.

Trustee Sue Deigaard: Each school will have multiple kits. Is there going to be campus training open to anyone interested in learning to use the kits, including teachers and students?

Lisa Blackman-Jones: A core of nurses will come to the school and train any campus members (students and staff).

# HISD Police Department Updates (Chief Pedro Lopez)

The HISD Police Department will participate in mandatory training August 3–14, 2020, at Madison High School. The mandatory classes are: Implicit Bias, Crisis Prevention Intervention, Report Writing, CPS Reporting Requirements, and Procedural Justice. In addition, ninety-one campus officers will be trained as basic instructors, certified for the state, in preparation to expand the TAPS program from nine campuses to 30 campuses. The department will also be conducting administrative tasks such as inventory of equipment and evidence disposal.
