Westbury High School and the parents of the students participating in activities, services, and programs funded by Title I, Part A of the Elementary and Secondary Education Act (ESEA), agree that this compact outlines how the parents, the entire school staff, and the students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership that will help children achieve the state's high standards.

SCHOOL RESPONSIBILITIES

Westbury High School will:

- 1. Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the state's student academic achievement standards as follows:
 - Employ highly qualified instructors;
 - Use the HISD instructional rubric to ensure effective and highly effective instruction in all classes;
 - Utilize high impact literacy strategies in all courses;
 - Provide independent reading materials for students and parents from the Independent Reading Level Assessment (IRLA) program and school library;
 - Collaborate with all stakeholders (e.g., parents/guardians, students, staff) as required to ensure student success on academic achievement tests (STAAR, TSI, PSAT, SAT etc.).
- 2. Provide parents with frequent reports on their child's progress. Specifically, the

school will provide reports as follows:

- Instructors will update grades in PowerSchool each week so that parents
 may view all student grades. Staff will be available to help parents log in
 to PowerSchool upon request. Students will receive progress reports every
 three weeks and report cards every six weeks.
- 3. Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows:
 - During conference times and when the consultation is convenient for both parties. All staff will respond to parents emails and calls within 48 hours.
- 4. Provide parents opportunities to volunteer and participate in their child's class and to observe classroom activities, as follows:
 - Parents may view each class when the principal provides permission.

PARENT RESPONSIBILITIES
