Call to order at 1:08.

Members present: Marcela Moore, Anne Johnson-Bacot, Maysoon Shahed, Diarra Hartle, Noe Ortega, Lizbeth Jara, Peta Douglas and Alexander S Rodriguez.

Formal introduction of September SDMC by school principal.

Check- In and Updates from committee members

- 1. Kinder: Jara
 - a. Some behavior issues here and there
 - b. Structures seem more solid from the start
 - c. Gaps between student levels (nonverbal students)
- 2. 1st Ortega:
 - a. Behavior issues in all the classrooms
 - b. One classroom seems to have more than average
 - c. Problem with getting breakfast on time
- 3. 2nd grade: Johnson
 - a. Students arriving late in combination with breakfast
 - b. 2 students already transferred
 - c. One class with major behavior issues is improving some, taking the class to the restroom has been a challenge
 - d. Starting to differentiate with lessons and activities for GT group
- 4. 3rd grade: Moore
 - a. Finishing BOY testing (RR)
 - b. Differentiating for special Ed students
 - c. Behavior- no major issues
 - d. Attendance has been good
- 5. 5th grade: Shahed
 - a. Started a lot smoother this year
 - b. Students are willing to learn, there are some struggling students need to differentiate for those
 - c. Attendance, a lot of students absent due to holidays
 - d. No major behavior issues
 - e. Restroom- at least twice a week students are making a mess on the floor

Overall feedback: Start of the year smooth!

School Improvement Plan (SIP)

- 1. Distributed to SDMC prior to meeting
- 2. Feedback on SIP:
 - a. SDMC membership: will be an election for vacancies listed at start of the document

- b. Add core enrichment, non-professional staff members and a parent to SDMC. Neighbor across the street will participate.
- c. Distinction designations
 - i. Improved in all areas except for writing
 - ii. Worked the most on closing the achievement gap and student growth and showed growth there 39→ 48
- d. Page 14 Marzano→ Hartle is already seeing this improve student learning by implementing this structure (will be in all contents)
- e. All objectives in SIP, teachers will be held accountable for (through monitoring)
- f. Professional development is targeted and differentiated
- 3. Reading Goals Feedback
 - a. Data Analysis
 - i. Will be a focus for this year, teachers and specialists need to know their students and be proactive
 - b. Structured literacy block in 4-5
 - i. Focus to be more purposeful in 3-5 and how lit by 3 is being implemented
 - ii. Will be connected to feedback
 - c. Think and Tap
 - i. Reading strategies for 3-5th grade students and teachers
- 4. Writing Goals feedback
 - a. Lucy Calkins K-1
 - i. How? PD will be provided for teachers before they implement the units
 - b. Units of study in 2-4 are being implemented with fidelity
 - c. Goal is that students can write across the content areas: reading will take you to college but writing will take you there (tied to post-secondary readiness index)
- 5. Math goals feedback
 - a. Venture math cohort
 - i. Monthly professional development for teachers (1/2 a day) as to not effect instruction
 - ii. Teachers need to make sure they give feedback to those giving professional development so that it is effective
 - b. Dreambox? is one of the instructional support strategies
 - i. More effective for the newcomers, was renewed for the campus
 - c. Small group instruction will be a big push
 - d. Math club? Think Through Math?
 - i. This deals with afterschool, would require a person to set up all the logistics
- 6. Post-Secondary Readiness feedback
 - a. More training for GT, project based learning, IIM, differentiation for these students
 - b. Focus on servicing GT kids
 - c. Need to be practical, focus on students that are ready
- 7. Federal System Safeguards feedback
 - a. Every child is serviced in a mainstream classroom, tested, growth, across subgroups
 - b. Need to focus on students in special education, making sure that their needs are met want a growth in 25% in student achievement) Norm is about 50% meeting the standard

- c. Need to revisit IEPs constantly to ensure students are making progress toward their goals
- 8. Attendance Plan Feedback
 - a. 97% or higher for this school year
 - b. Home visits, awards for perfect attendance
 - c. Now that teachers have phones, have some kind of communication going on with parents and students
- 9. Behavior Plan Feedback
 - a. Circle: has to have teacher and student buy in in order to be an effective strategy
 - b. Restorative practices: will there be more training for teachers
 - i. REQUEST: more professional development for teachers on word choice, conversations, conferences with students
- c. Decrease in school suspension for boys-> will try to improve through mentor program

 10. Safety Feedback
- a. Need training on how to deal with bullying and situations, for students and parents too 11. PBIS feedback
 - a. Behavior implementation system: conduct folders in upper grades
 - b. 3rd grade conduct page, conferences and phone calls
 - c. 2nd grade parents really like the classroom dojo (shooting for 90% parent participation)
 - i. Students coaching others for behavior
 - d. Lower grades, constant parent communication and movement of the clips
- 12. Parent and Community Engagement
 - a. Afterschool program is working really well so far
 - b. ESL for parents
 - c. State of Texas: Ready Rosie, parents sign up and there are resources on behavior, parenting literacy etc.
 - d. Parent teacher partnership through home visits
 - e. Mentoring through Sasol, big brothers and big sisters
- 13. Coordinated Health
 - a. Increasing parent buy in to programs helping students receive health services (eye glasses, dentist etc.)
 - b. Refer kids that might be at risk for diabetes
 - c. BMI goals for PE teachers
- 14. Special populations and goals
 - a. Dyslexia and special education students
 - b. Homogenous grouping for GT
 - c. Focusing on special ed students
