SUBJECT: **2022 TEA FINAL ACCOUNTABILITY RATINGS REPORT**

The attached report summarizes the final accountability ratings mailed by the Texas Education Agency (TEA) on November 16, 2022. Preliminary ratings were released on August 15, 2022. HISD appealed four of the preliminary ratings, and TEA **granted the appeal for Community Services changing its overall and domain ratings from Not Rated: Senate Bill 1365 to Not Rated. The other three appeals were denied.**

**Key findings include:**

- Houston ISD maintained an overall B rating from 2019 with a score of 88.
- 96 (35%) campuses earned an A rating, up 39 campuses from 2019.
- 94% of campuses earned A, B, or C ratings, up from 82% in 2019.
- 78% of campuses earned A or B ratings, up from 50% in 2019.
- Wheatley HS, after 8 years of unacceptable performance (including one year of no rating due to Harvey), earned a C.
- Henry Middle School, after four years of unacceptable performance and then a D in 2019, earned a C.
- Osborne Elementary moved from a 59-F in 2019 to a 96-A in 2022 – a district-high 37-point increase
- 79 campuses increased their overall rating score by ten or more points
- 243 campuses were eligible this year for Distinction Designations.
- 169 campuses (70% of those eligible) received at least one Distinction Designation.
- 22 campuses (9% of those eligible) received every eligible Distinction Designation.

# Texas Education Agency Final Accountability Ratings Report 2021–2022

The 2022 accountability system uses a performance framework that consists of three domains. Detailed information on each of the three domains, including construction of the domains, scoring tables, minimum size requirements and exclusions can be found in the Texas Education Agency's (TEA) 2022 Accountability Manual which can be downloaded from the [Research and Accountability website](#). All campuses and districts in Texas were labeled *Not Rated: Declared State of Disaster* in 2020 and 2021 due to the impact of COVID-19. For 2021–2022, all campuses were labeled A, B, C or *Not Rated -SB 1365*. Comparisons will be drawn from 2018–2019 and 2021–2022 for this report. TEA's overview is provided in **Appendix A**. The three domains are:

## **Domain 1 – Student Achievement**

Evaluates performance across all subjects for all students, on both general and alternate assessments, College, Career, and Military Readiness (CCMR) indicators, and graduation rates.

## **Domain 2 – School Progress**

Measures district and campus outcomes in two areas: the number of students that grew at least one year academically (or are on track) as measured by STAAR results and the achievement of all students relative to districts or campuses with similar economically disadvantaged percentages.

## **Domain 3 – Closing the Gaps**

Uses disaggregated data to demonstrate differentials among racial/ethnic groups, socioeconomic backgrounds, and other factors. The indicators included in this domain, as well as the domain's construction, align the state accountability system with the federal Every Student Succeeds Act (ESSA).

Raw scores in each domain are converted to a consistent scale and weighted to give campuses and districts an overall rating. To receive a rating at or above a *D*, districts and campuses must have an overall rating calculation of at least 60 with 70% of the overall calculation coming from the better outcome of the Student Achievement and School Progress domains and 30% of the calculation coming from the Closing the Gaps domain. In addition, if a campus or district receives less than a scaled score of 60 in three of the four areas (Domain 1, 2A, 2B, or 3), then the highest overall scaled score possible is 59. The domain and overall 2021–2022 ratings are based on the scaled score targets presented in **Table 1**.

Houston ISD received a grade of **B** based on an overall score of 88 for the 2021–2022 school year. The district received the scaled scores and corresponding letter grade for the three domains as follows:

- **Domain 1 Score: 78** Rating: **C**
- **Domain 2 Score: 89** Rating: **B**
- **Domain 3 Score: 86** Rating: **B**
- **Overall Score: 88** Rating: **B**

Campuses received an A–F letter grade for the first time in the 2018–2019 school year. Due to COVID-19, campuses were *Not Rated* – SB 1365 if they were assigned a letter grade of D or F in 2021–2022. **Table 2** shows the number of campuses rated *F*, *D* or higher, or *Not Rated* from 2018–2019. For 2021–2022, all campuses were labeled A, B, C, *Not Rated*, or *Not Rated* -SB 1365.

- 4 campuses were identified for Comprehensive Support and Improvement for at least four of the following reasons:
  - It was a Title I campus, and its Domain 3 by scale score was among the lowest five percent of Title I campuses by school type in the state and its overall scaled score was among the lowest five percent of Title I campuses for all school types.
  - Its four-year federal graduation rate was less than 67 percent.
  - It was a Title I campus and was identified for additional targeted support and improvement for three consecutive years.
  - Was identified as a Comprehensive Support and Improvement campus last year and did not rank in their school type's bottom five percent of the Closing the Gaps domain for two consecutive years or has an overall scaled score that falls within the lowest percentile.
- 43 campuses were identified for Targeted Support and Improvement for having at least one student group in Domain 3 that missed the targets in the same three indicators for three consecutive years and were not already identified for Comprehensive Support and Improvement.
- 3 campuses were identified for Additional Targeted Support and Improvement for having at least one consistently underperforming student group and having at least one consistently underperforming student group that did not meet any of its evaluated indicators for three consecutive years.

- 243 campuses were eligible this year for Distinction Designations.
- 169 campuses (**70%** of those eligible) received at least one Distinction Designation.
- 22 campuses (**9%** of those eligible) received every eligible Distinction Designation.

Complete scoring information on all campuses can be found in **Tables 6–10**, TEA's accountability summary reference is provided in **Appendix A**, and TEA's complete list of indicators for the distinction designations are listed in **Appendix B**.

All campuses serving grades PK–12 must receive an accountability rating. However, campuses with no state assessment results due to grade span served (i.e. PK–2) are incorporated into the accountability system by having districts choose another campus within the same district or the district itself with which to pair for accountability purposes. These campuses receive a rating based solely on the paired campus' or district's performance. These campuses, along with their pairs, are also identified in **Table 6**. Campuses that do not receive a rating due to an insufficient number of tested students or because their results are attributed to their students' home campuses are identified in **Table 5**.
