Parent/Family Engagement within the Policy

Parent meetings and conferences are held at different times during the school year.

Title I funds may be used for summer school, a full-day pre-kindergarten program, after-school tutorials, and community/counselor resources.

Parents will be given timely information about the Title I program using Class Dojo, a FERPA-approved platform, including newsletters, a monthly calendar of events, and school messenger. Paper copies will be provided to parents without access to the internet upon request.

Parents will be provided a description and explanation of the curriculum taught, the types of academic assessments used to measure student progress and proficiency levels, and expected scores to be achieved on the STARR, TELPAS, Renaissance, Eureka, Zearn, Fountas, Pinnell, and High-Frequency Word Evaluations.

Additional resources are available to students at school or at home. These resources will be posted on Class Dojo, a FERPA-approved platform.

Opportunities are provided for parents to be actively involved in their child's education through a variety of school-sponsored events such as:

- *Family Curriculum Night*
- *Coffee with the principal*
- *Title I Parent Meetings at a minimum of 8 per year*
- *School-Sponsored Events and Celebrations Throughout the School Year*

Parent/Family Engagement within the Program

During the scheduled parent meetings, parents will be given timely information about the Title I program, including Fountas and Pinnell, tutoring services, computer lab, and after-school activities.

The designated staff member will describe the curriculum, expectations for all students, and how all student performance is measured.

The parents are given an explanation of their individual child's performance and school performance for State tests, such as STARR, and other measures of academic performance, which include tests such as High-Frequency Word Evaluation, Ren360, Running Records, Zearn, and Eureka.

Parent/Family Engagement and Parent Training

Parent meetings, workshops, and presentations are held to help parents of enrolled students at Roland P. Harris Elementary School understand the performance level of their students, educate parents on how to work collectively with teachers and staff to help their child, and how to be actively involved in decision-making about the education of their child.

The teachers and faculty are trained on the importance of parental involvement.


