Enrollment/ Staff/ Program Updates	<ul style="list-style-type: none"> Current student enrollment is 1267. Our campus projection for the current school year is 1327. If enrollment projections are not met, we will need to pay-back funds to the state. District enrollment is down 22K. Possible reasons for students not enrolled could include (1) attending charter schools, (2) moving to other districts, (3) home-schooling, (4) private schools. Staff – Added an additional Social Studies teacher, 15 new staff members where 3 are brand new teachers. The majority of our teachers moved to areas closer to their homes, out-of-state. 2 switched professions. Added Programs – Thinking Skills class for Vanguard Students, Dual Language in 6th and 7th Social Studies, Creative Writing class for 6th and 7th Graders. 	Monitor daily enrollment; call our no-shows to determine their location.
