Dogan Elementary will convene an annual parent meeting offered during various times to accommodate parents, to which all parents of participating children shall be invite and encouraged to attend, to inform parents of their school's participation under this part and to explain the requirements of this part, and the right of the parents to be involved. The annual parent meeting is to allow parents the opportunity to review and revise the current PFE policy via campus survey. Once the policy is reviewed and updated it will be distributed and explained to parents. Dogan will distribute the revised policy via written communication in both English/Spanish and posting to school website under the Title I tab.

Dogan Elementary shall offer a flexible number of meetings, such as meetings in the morning or evening, and may provide, with funds provided under this part, transportation, childcare or home visits, as such services relate to parental involvement.

If the schoolwide program plan (Campus Improvement Plan, CIP) under section 1114(b) is not satisfactory to the parents of participating children, submit any parent comments on the plan when the school makes the plan available to the local educational agency. Section 1116 (c)(5)

To ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, Dogan Elementary shall: Section 1116 (e)

(i)provide assistance to parents of children served by the school, as appropriate, in understanding such topics as the challenging State academic standards, State and local academic assessments, the requirements of this part, and how to monitor your child's progress and work with educators to improve the achievement of their children.

(ii)provide materials and training to help parents to work with their children to improve their children's achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parental involvement. Section 1116 (e)(2)

(iii)educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school. (iv)to the extent feasible and appropriate, coordinate and integrate parent involvement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children.

(v)provide such other reasonable support for parental involvement activities as parents may request.

Section 1116 (e)(14)

- 1. Dogan Elementary will review the Parent and Family Engagement Policy with parents, family members, and the community during a morning and afternoon meeting. The Parent and Family Engagement Policy will be reviewed on a yearly basis and revised if deemed necessary based on the needs of the campus. Parents and family members are encouraged to participate in the writing process of the Parent and Family Engagement Policy. Parents are given the opportunity to participate in the writing process during the development by use of parent surveys, reviewing, revising, and agreeing upon the Parent and Family Engagement Policy.
- 2. Dogan Elementary will convene four annual Title 1 meetings in the Fall of 2022 and four in the Spring of 2023. Two of the Fall 2022 meetings will convene in the morning during school hours and two meetings will convene in the evening to allow all parents the opportunity to attend. The morning meeting will contain the same information as the evening meeting as a TEA requirement. Two of the Spring 2022 meetings will convene in the morning during school hours and two will convene in the evening to allow all parents the opportunity to attend. Due to the Covid-19 epidemic and the need to take all necessary steps to protect the health of District students and personnel and the community at large some meeting may be offered virtually through Microsoft Teams and others face-to-face at school. Parents will be notified of the Title I meetings through:

- 3. Dogan Elementary shall allow parents to participate in developing the PFE program and activities during Title I part A meetings, SDMC meetings, and other parent meetings. At which Parent and Family Engagement Policy will be reviewed and revised for the current school year and revisit on a yearly basis to meet the needs of the campus. The parents' role when developing the School Improvement Plan (SIP) is instrumental in allowing input from the parents and community. Parental and community involvement will allow adequate representation of all student demographic populations represented on campus, including parents of migrant students and/or parents of special education students. Dogan Elementary at the request of parents will provide opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions about the academic progress and education of their children.
