- The meeting began at 5:05 pm.
  - Welcome and introduction by Christy Dafonte, DAC Facilitator
  - An overview of collective purpose of the DAC was shared.
    - To promote excellence in education and specialized supports for all HISD students through community representation.
    - The DAC provides valuable input to the Superintendent and his leadership team and the Board of Trustees, who ultimately have decision-making responsibility for the district.
  - Meeting Norms and Padlet Instructions
    - A Padlet was shared to serve as a DAC meeting parking lot for all DAC meetings to enable sharing of questions and comments for future follow-up not directly relevant to the agenda topics of each respective meeting
  - DAC Co-Chair Elections: Conducted via a poll in TEAMS. There were 2 members who submitted votes via email. Winner was Daniel Santos and the winner of the run-off vote between Naomi and Gregory was Naomi Doyle-Madrid. Run-off voting held at end of meeting.
  - Student/Parent Handbook- Roshunda Roberts Jackson, Exec Director Federal & State Compliance
    - This was presentation #2 for Student/Parent Handbook, continuation of discussion from December meeting.
    - Shared link in chat to entire Student/Parent Handbook so members could review and provide feedback on Part 2, starting on page 27.
    - Handbook has been shared with district leadership and selected principals.
    - Provided survey so members could provide feedback on pages 27-end of handbook. . Deadline for feedback is March 24, 2023.

- Dropout Prevention- Glenda Calloway, Exec Director Counseling & Compliance
  - Discussed district plan for drop-out prevention as it pertains to the non-Instructional side.
  - Explained how state calculates and classifies a student as a dropout. Explained deadlines for classifications of students. Explained indicators that qualified students as At-Risk.
  - Brock Re-Engagement Center
  - Discussion of new supports and/or programs starting in 22-23 SY to identify and support At-Risk students.
- TAPR- Robert Reeves, Sr. Manager Performance & Accountability
  - Reviewed 2021-22 TAPR report (which is a lagging report that's not available until the Spring of the following school year).
  - The report covers demographics and STAAR performance broken down by student subgroups/populations and compares HISD performance to the state of Texas as a whole.
  - Overall HISD improved in # of students performing at Meets on STAAR from prior year. However, many subgroups are still performing below the state average performance.
  - Graduation rate is increasing compared to prior year and student drop out is decreasing across all student subgroups.
  - Other topics reviewed include SAT/ACT participation, AP/IB exam participation and performance, College/Career/Military Readiness, Enrollment in Higher Education, Staffing, and Salary.
